I find it hard to believe that the 3 alternatives for Section 3 (Downtown Loop) are the best that TXDOT can offer. 2/3 of these alternatives eliminate the Pierce Elevated seriously? We have a need for more options, not less. I feel these two (alt. 11 and 12) are not taking Houston in the right direction. Additionally, a new, massive expansion of 59 past the Convention Center would create a physical and mental barrier that would separate the east side and end the economic development going on there. More thought should be given to "how" to construct these elevated sections so that Houston can make use of the property below the road. As they are presented, I strongly oppose alt. 11 and alt. 12.
